**COVENANT NOT TO SUE AND AGREEMENT TO HOLD HARMLESS**

In consideration for receiving permission to participate in the Digital Filmmaking Camp sponsored by Henderson State University, I, the undersigned, execute this Covenant Not to Sue and Agreement to Hold Harmless voluntarily to bind myself, my child, my family and heirs. I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE, AND AGREE TO HOLD HARMLESS for any and all purposes Henderson State University, the Board of Trustees of Henderson State University, and their officers, servants, agents, volunteers, or employees (herein referred to as RELEASEES) FROM ANY AND ALL LIABILITIES, CLAIMS, DEMANDS, OR INJURY, INCLUDING DEATH, that may be sustained by me while I am a participant in the activity, using equipment owned or provided by the RELEASEES or while on the premises owned or leased by RELEASEES, including injuries sustained as a result of the negligence of RELEASEES. I know of no medical reason why my child should not participate in this activity.

I am fully aware that there are inherent risks involved with participating in this activity, including, but not limited to, property damage and serious personal injury to me, including death, and I choose to voluntarily allow my child to participate in the activity with full knowledge that doing so may be hazardous to my child and his/her/my property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH that may be sustained by my child as a result of participating, including injuries sustained as a result of the negligence of the releases.

It is my express intent that this Covenant Not to Sue and Agreement to Hold Harmless shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representatives, if I am deceased, and shall be governed by the laws of the State of Arkansas. Nothing in this Covenant Not to Sue and Agreement to Hold Harmless shall be deemed to waive the sovereign immunity of Henderson State University.

Pursuant to A.C.A. §19-10-204, the Arkansas State Claims Commission shall have jurisdiction over any dispute regarding my participation in this activity and this Covenant Not to Sue and Agreement to Hold Harmless.

In signing this Covenant Not to Sue and Agreement to Hold Harmless, I acknowledge and represent that I have read the foregoing Covenant Not to Sue and Agreement to Hold Harmless, I have had the opportunity to ask questions, I understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements apart from the foregoing agreement that has been reduced to writing have been made. I execute this document for full, adequate and complete consideration fully intending to be bound by the same, now and in the future.

Parents and guardians must be attentive to picking up their children on time as Releasees will PROVIDE NO SUPERVISION OF STUDENTS BEYOND THE TIME LIMITS OF THE SCHEDULED SESSION OR ACTIVITY FOR THOSE NOT STAYING ON CAMPUS. Releasees reserve the right to dismiss any student who repeatedly arrives late for sessions/activities, sessions/activities, or does not participate in or prepare for sessions and group activities according to the Instructor’s requirements. Class disruption or disrespectful behavior is grounds for dismissal at any time.
